Call to order: Sam Hayden called the meeting to order at 5:30pm

Adoption of agenda: Josh motioned to adopt the agenda. Daron seconded and it was passed unanimously.

Staff Reports: The board looked over the rest of the staff reports.

New Business: A- Tour the facilities: -Baseball fields: The board first stopped at the baseball fields during their tour. The batting cages are getting worked on. Dugouts will be worked on for upcoming season and announcer's booth will get fresh paint.

-**The softball fields** were next, and Kristi Anderson let the board know that the yellow covering that goes on the fence on the south field has been ordered and will be on for the next season. She also let them know that the south dug out roof will be worked on as well. Sam Hayden asked Kristi for a plan of how and when the dugouts will be done.

-**The Activity Center** was the next stop. Kristi Anderson let the board know that there is a plan for the new flooring that will go in the gym. We hope to have the flooring installed in January or February 2023.

-**The TS Building and Wellness Building** were the next stops. Kristi Anderson talked to the board about getting all the concrete flooring covered in the gymnastics area so that we could maybe host meets in the future. There are also 2 large cracks that the board looked at in the TS building. in the flooring.

-**The final stop was at the pool.** Kristi let the board know that the pool needs humidity control in the indoor pool area. The paint on the walls is peeling off due to the humidity.

B- Pool: Kristi let the board know that the pool needs a new pool heater. Weber came to look at it and gave a quote for a new one that will take 9 weeks to get in. The board asked Kristi to get another quote from somewhere else as well.

C- Gymnastics: Kristi let the board know that she budgeted some money for the gymnastics room, and she would like to purchase some new rolled mats from Gym Supply. They gave us a quote for some new mats that

total \$7056. Daron made a motion to buy the mats from Gym Supply for \$7056. Josh seconded the motion and was passed by all.

Our pool heater is limping along. We are having to restart the heater when it decides to go off. We don't have any idea why it decides to turn off. This heater that we have, has only been in service for 5.5 years. The previous heater worked for 12+ years. We will be adding a regular maintenance program to what ever we decide to purchase. The County Commissioners have given us ½ of the price of the lesser cost heater, minus the Drug and Alcohol Tax. (\$1,880.20) We will need to take the other part of the cost out of Swimming Pool Budget and Capital Outlay.

Hope to get that ordered after the Board Meeting this month. The pool humidity controller is out also. We are waiting for a replacement part to be installed. With the humidity being so high in the pool area we are having paint peel. As soon as we get the humidity under control we can scrape and repaint in the indoor pool.

The gymnastics team have started to pay for meets that are scheduled in January. Most meets' fees are due 4-6 weeks before the meet date. They have checked out their team leotards and will have a photo day first part of January. The stock of leotards is still looking excellent. We are charging a rent fee and taking a Deposit for the full price of the leotard. The parents are given instructions on how to take care of the leotard. So far, we they have done a good job.

Our Company Christmas Party will be held December 10th at Bonnie and Clyde's Restaurant in Hugoton. A game or two of bowing will be following our return. Sounds like a night of food and fun. November Board Report


- The cover is repaired on the pool. It has helped with condensation in the pool area.

- Fence cap has come in and we have started to get it put on. I decided to go with a black fence cap to continue with a Black field(south) and an orange field(north) theme. We also need to replace the back stop padding, so I will be looking at doing that in black as well.
- On the south field dugouts, I want to expand them a little bit to allow more bench space. Currently the dugout is 20ft x 6ft with a bench that is 16ft. I want to expand them to 30'x8' with a bench that is around 24ft which will be like the Legion dugouts. So as far as design, I am looking at something like the Legion field dugouts but will build them out of wood and finish with some sort of siding with a metal roof. Something like this picture, but with a door opening on one end and then a half wall on the other end.



• I am not sure of timing on this project. We will need to expand our current concrete pads first. I also want to sit down and talk with someone knowledgeable about how to build them, what to do and not do so they are done right and will last. So, if I think I can get them done before next spring and I have the budget to do it then that's what I will do. Otherwise, I will fix the existing covers to make it through the next summer.
