Consent agenda: Jen moved to approve the regular board minutes dated November 7, 2022, payroll, and accounts payable totaling \$100,923.13 for the month of November 2022 and to accept the treasurer's report as presented. Josh seconded and it was passed unanimously.

Treasurer's report: Daron gave the treasurers report.

Old Business: A- Sharks Coaches Contract- Willa Eddie spoke on behalf of Sharks coach. The swim board is asking for \$500 to be paid to Aleisha for the fall season. They spoke about the number of kids that are in fall swim team and how many are improving in their swim and times. Jen motioned to pay \$500 to swim coach Aleisha for the fall season. Amy seconded and it was passed by all. Kristi Anderson will add that into her contract and have it ready for Aleisha to sign and the board as well.

B- Pool Heater- The board looked over bids for a new pool heater from ACC and Weber's. The county agreed to pay \$7,095 of the heater costs. The board discussed the bids and Jen made the motion to go with ACC's bid of \$21,333.00 for a LAARS MIGHTY THERM 2 750 with a 1-year parts and labor warranty.

New Business: A- Phone Stipend- It was discussed and tabled for another meeting time.

B- CD Interest- Kristi Anderson got Daron numbers on the different interest rates that the rec CD's have at Bank of Ulysses and Dream First Bank. Jen asked what the penalties are if we pull the CD out early. Kristi will look into that and will let the board know later.

C- Sales Tax- Kristi A discussed with the board that sales tax is different now for different items that we sell. She would like to just pay the higher tax amount of 6.5% on all items that are sold in our concessions. The board talked and agreed that it would be ok to do that instead of the two different tax rates.

Jen called for an executive session for reason #1 not to exceed 15 minutes. Josh seconded. Board came out at 6:20pm and went back in for another executive reason #1 at 6:21pm. The board came out at 6:26pm with no action taken.

- Working on getting the machines serviced up for spring. Some we will do now and some we'll wait to service when we get them out of storage closer to spring time.
